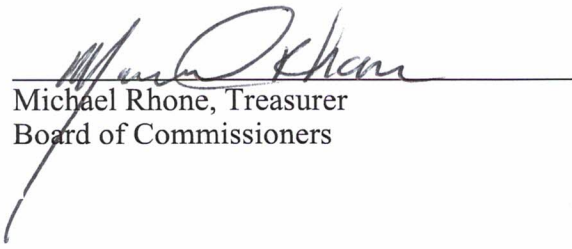

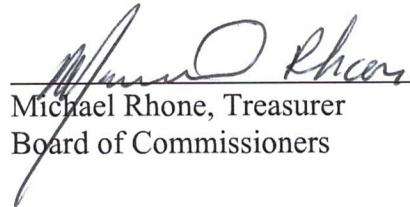
RESOLUTION ADOPTING BUDGET

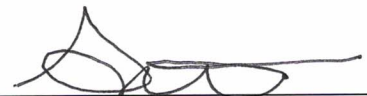
